## NSLI Year in Review

Over the past year, the National Sports Law Institute (NSLI) has undergone significant changes but has continued to encourage study of legal issues in amateur and professional sports, to promote informed and ethical practices in the sports industry, and to serve as a resource for sports law students, attorneys and business professionals.

### NEW LEADERSHIP

In August of 1999, Professor Matthew J. Mitten joined the National Sports Law Institute as its fourth Director. Director Mitten's leadership and vision have become readily apparent as reflected by revision of Marquette University Law School's sports law curriculum, implementation of a sports law certificate program and reconstitution of the NSLI's Board of Advisors. As the first full-time Director of the NSLI Professor Mitten's commitment to the growth of the Institute and Marquette's sports law program will lead the Institute into the 21st century. He is the current Chair of the American Association of Law School's Law and Sports Section and a member of the NCAA's Committee on Competitive Safeguards and Medical Aspects of Sports:

### NSLI SPORTS LAW CERTIFICATE

Students graduating from the Marquette University Law School in the Spring 2000 semester or thereafter are eligible to earn a sports law certificate. In the Spring semester of each year the NSLI will present the certificate

to each graduate who has satisfied the following requirements:

- 1) Both basic sports law courses (each 2 credit hours): Amateur Sports Law, and Professional Sports Law;
- 2) A sports law workshop (2 credit hours) Sports Industry Contracts and Negotiations or Sports Industry Legal and Business Practices
- 3) A sports law seminar (2 credit hours) Sports, Law and Society Seminar or Selected Topics in Sports Law or Independent Study in Sports Law
- 4) Topics in Advanced Legal Research-Sports Law (1 credit hour)
- 5) One of the following courses  
Alternative Dispute Resolution, Arbitration Workshop, Mediation Workshop, or Negotiation Workshop
- 6) One or more of the following substantive law courses that significantly impact the sports industry  
Antitrust Law, Business Associations, Constitutional Law 2: Speech and Equality, Copyrights, Disability Law, Federal Income Taxation of Individuals, Labor Law, or Trademarks
- 7) *Marquette Sports Law Journal* editorial or staff position for a full academic year; and
- 8) A one semester NSLI sponsored volunteer sports law internship

The first certificates will be awarded in the Spring of 2000 during the NSLI's annual awards dinner.

### SPORTS LAW CURRICULUM

Under the guidance of Director Matt Mitten the sports law curriculum at Marquette University Law School has been refined to eliminate unnecessary overlap and fill in

gaps in course coverage. Marquette's sports law program now consists of eight courses making it the most extensive law school curriculum in the country.

### AWARDS & SCHOLARSHIPS

#### Joseph E. O'Neill Award

The Joseph E. O'Neill Award was established by the O'Neill family, the Milwaukee law firm of Davis Kuelthau, S.C. and the National Sports Law Institute after Mr. O'Neill's untimely death in 1992. The award is given annually to an individual in the sports industry who has made a significant contribution to the field and done so while exemplifying the highest ethical standards. The 1999 recipient of the Award was Daniel R. Doucette, President and Principal Owner of the Milwaukee Rampage and the Wisconsin Rebels, NSLI Board Member, and President and Chief Executive Officer of Milwaukee Mutual Insurance Company.

#### Joseph E. O'Neill Prize for Student Writing

Each year since 1997, the Joseph E. O'Neill Prize for Student Writing has been awarded to the MARQUETTE SPORTS LAW JOURNAL member who authors the best student article published during the previous academic year. In April of 1999, the Prize was presented to two third year law students: Editor-in-Chief April R. Anderson for her article titled "The Punch That Landed: The Professional Boxing Safety Act of 1996," (Vol. 9, pgs. 191-215) and Executive Editor Amy E. Worden for her article titled, "Gaining Entry: The New O and P Categories for Nonimmigrant Alien Athletes" (Vol. 9, pgs. 467-494).

Martin J. Greenberg Award

During the fall of 1997, the NSLI also established the Martin J. Greenberg Award for excellence in the study of sports law in honor of former NSLI Director Martin J. Greenberg. The 1999 winner of this award was April R. Anderson, Editor-in-Chief of THE MARQUETTE SPORTS LAW JOURNAL and the first student to substantially complete the new sports law curriculum at Marquette University Law School.

Francis D. and Jane Keogh Kelly Scholarship.

The Francis and Jane Keogh Kelly Scholarship was established in 1997 to recognize a student in the Sports Law program at Marquette for excellence in the study of sports law and service to the sports law program at Marquette. Since that time the National Sports Law Institute has awarded this scholarship to the Editor-in-Chief of the MARQUETTE SPORTS LAW JOURNAL in recognition of his/her extraordinary contribution to Marquette's Sports Law Program at Marquette. The 1999-2000 recipient of this scholarship is current Editor-in-Chief, Eryn Doherty.

## PUBLICATIONS

### Marquette Sports Law Journal

In the Spring of 1999, under the direction of former Editor-in-Chief April Anderson, the JOURNAL published two symposiums. The first issue included articles based on presentations given at the NSLI's "Sports Law in the 21st Century" Conference held in 1998. Topics covered included globalizing sports law, racial issues in the NBA, taxation issues in professional sports, and Title IX.

The second symposium contained articles focusing on the recently passed Curt Flood Act. Noted scholars such as Roger I. Abrams, Edmund P. Edmonds, and Gary Roberts presented their analysis of this Act and its potential affects on professional baseball.

Under the direction of current Editor-in-Chief Eryn Doherty and JOURNAL Supervisor Paul Anderson, the Fall 1999 issue of the JOURNAL, Volume 10, Number 1, will be published shortly and include articles on topics such as the Chicago Bulls vs. WGN case, the right of publicity, antitrust regulation of the NCAA, and athletes with eating disorders.

In the Spring of 2000 the Journal will publish a symposium issue devoted entirely to sports facilities and development.

In the past year the NSLI has published the 1999 Spring, Summer and Fall editions of YOU MAKE THE CALL. . ., a newsletter that provides synopses of recent cases in the sports law field. Cases reported in these issues include:

Volume 1, Number 4 (Spring 1999): NBA Arbitration (Arbitration deciding that players did not need to be paid during lockout); Major League Baseball Umpires Arbitration (Supreme Court denies review of umpires' compensation grievance); Oakland Raiders v. NFL (Raiders trademark dispute); Davis v. Baylor University (college recruiting case); and Brentwood Academy v. TSSAA (high school recruiting rule case).

Volume 2, Number 1 (Summer 1999): Minnesota Twins Partnership v. State of Minnesota (Twins exempt from antitrust investigation); Shaw v. Dallas Cowboys Football Club (satellite broadcasts of NFL games); Ortiz-Del Valle v. NBA (female referee's discrimination suit against the NBA); Adidas America v. NCAA (Adidas antitrust suit against NCAA); Baum Research & Development v. Hillerich & Bradsby Co. (bat manufacturer antitrust suit against NCAA); Alston v. Virginia High School League (high school Title IX suit); Miller v. Wilkes (high school drug testing case); and Caruso v. Blockbuster (wheelchair access to entertainment facility).

Volume 2, Number 2 (Fall 1999): Brentwood Academy v. TSSAA (TSSAA not a state actor and can use recruiting rule); Mercer v. Duke University (contact sports exception under Title IX); Adidas America v. NCAA (Adidas antitrust claims dismissed); Montalvo v. Radcliffe (participation under the ADA with AIDS); Olinger v. USGA (use of golf cart not allowed under ADA); & Giordano v. Ridge (taxpayer suit against use of tax money for sports facilities).

The past year has also seen the introduction of **webfinds** which provide web based links to cases reported in YOU MAKE THE CALL...

### SPORTS LAW & REGULATION

In the Fall of 1999, the NSLI introduced SPORTS LAW & REGULATION, edited by Professor Joseph Gordon Hylton and NSLI Assistant Director Paul M. Anderson. The book contains essays on various topics in the sports industry

to help readers understand the developing legal framework that shapes the sports world. The book is available for \$24.95 from the NSLI.
